

WHEREAS; the parties wish to enter into a Contract for Services setting forth their agreement regarding the services to be provided and other matters;


WHEREAS; This contract shall be effective April 11, 2023, and ends April 11, 2024, unless terminated earlier by the Carbon County Library due to a lack of funding for the continuation of library services in the Town of Hanna, with written notice provided to the Town of Hanna;

NOW, THEREFORE, BE IT RESOLVED BY THE GOVERNING BODY OF THE TOWN OF HANNA, WYOMING, that the Mayor is authorized and directed to execute the contract in the form attached hereto, and the Town Clerk/Treasurer is authorized and directed to attest in the same and affix the Seal of the Town of Hanna, Carbon County, Wyoming, said agreement being attached hereto.

**PURCHASE OF SERVICE CONTRACT WITH CARBON COUNTY LIBRARY FOR
THE HANNA PUBLIC LIBRARY BRANCH**

I. PARTIES,

THIS CONTRACT is made and entered into by and between the Town of Hanna, Wyoming and the Carbon County Public Library, whose address is 215 W. Buffalo Street, Rawlins, Wyoming 82301, hereinafter referred to as "Provider".

II. INTRODUCTION,

THAT WHEREAS, the purpose of this contract is to provide library services for the citizens of the Town of Hanna, Carbon County, Wyoming.

WHEREAS, it is the wish of the Mayor and Council Members of the Town of Hanna to allow for the purchase of services for the citizens; and

WHEREAS, the Provider is qualified to engage in the provision of such services; and

WHEREAS, the Town wishes to ensure such services are available to the citizens of the Town from the Provider.

NOW THEREFORE, in consideration of the mutual covenants and agreements Contained herein, it is mutually agreed as follows:

- A. The Town of Hanna hereby agrees to pay monies towards the Black Hills Energy Gas Utility Bill for the Hanna Public library located at 300 North 3rd St., Hanna, Wyoming 82327, with monies from the 1% Sales Tax Funds of the General fund, the town agrees to pay Fifteen Hundred Dollars (\$1,500.00) per year towards the gas bill and provide water service utility which is estimated to be Twelve Hundred Dollars (\$1,200.00) per year, after both parties have signed this Purchase of Service Contract.
- B. That for and in consideration of said money, the Provider hereby, agrees to provide library services for the citizens of the Town of Hanna, Wyoming, and to provide monthly board meeting minutes, and financials to the Mayor and Town Council, via email to the Town Clerk at clerk@townofhanna.com prior to the Town council meetings on the 2nd Tuesday of each month, for review.
- C. This contract shall be effective April, 11th 2023 and ends April, 11 2024.


