


WHEREAS; the parties wish to enter into a Contract for Services setting forth their agreement regarding the services to be provided and other matters;

PURCHASE OF SERVICE CONTRACT WITH HANNA BASIN HISTORICAL SOCIETY

I. PARTIES,

THIS CONTRACT is made and entered into by and between the Town of Hanna, Wyoming and Hanna Basin Historical Society, whose address is P.O. BOX 252 Hanna, Wyoming 82327, hereinafter referred to as "Provider".

II. INTRODUCTION,

THAT WHEREAS, the purpose of this contract is to provide a museum for the patrons of the Town of Hanna, Carbon County, Wyoming.

WHEREAS, it is the wish of the Mayor and Council Members of the Town of Hanna to allow for the purchase of services for the patrons; and

WHEREAS, the Provider is qualified to engage in the provision of such services; and


WHEREAS, the Town wishes to ensure such services are available to the patrons of the Town from the Provider.

NOW THEREFORE, in consideration of the mutual covenants and agreements contained herein, it is mutually agreed as follows:


- A. The Town of Hanna hereby agrees to pay the Black Hills Energy gas utility bill and the Rocky Mountain Power electric bill for the Hanna Basin Museum located at 506 Front Street, Hanna, Wyoming, for the approximate sum of five thousand and five hundred dollars (\$5,500.00) per fiscal year, and provide water, sewer, landfill services for the approximate sum of twelve hundred dollars (\$1,200.00), with monies from the 1% sales tax funds of the General Fund, to be paid each month, after both parties have signed this Purchase of Service Contract.
- B. The Town agrees to assist with snow removal, mowing, trimming, and care for the sprinkler system.
- C. That for and in consideration of said money, the Provider hereby agrees to provide a museum for the patrons of the Town of Hanna, Wyoming, and to provide monthly board meeting minutes and financials to the Mayor and Town Council via email to the Town Clerk at clerk@townofhanna.com prior to the Town Councils meeting on the 2nd Tuesday of each month for review.
- D. This contract shall be effective February 15th, 2023 and ends February 15th, 2024.

IN WITNESS WHEREOF, the Mayor and Council Members of the Town of Hanna, Wyoming, and the Provider have executed this contract on the 15th day of February, 2023.


