RESOLUTION 2024-609

A RESOLUTION AMENDING THE EXPENDITURES FOR THE TOWN OF HANNA, WYOMING FOR THE FISCAL YEAR OF JULY 1, 2024 THROUGH JUNE 30, 2025.

BE IT RESOLVED BY THE COUNCIL OF THE TOWN OF HANNA, WYOMING:

WHEREAS, the Town, pursuant to Wyo. Stat. § 16-4-112, may transfer any unencumbered or unexpended appropriation balance or part thereof from one fund to another upon the request of the Town Budget Officer; and

WHEREAS, the transfer of the unexpended appropriate to the general fund is permissible under Wyo. Stat. § 16-4-112 and the budget of the general fund may be increased pursuant to Wyo. Stat. § 16-4-113; and

WHEREAS, an approval of the Town Hall Roof Project indicates a need to adjust previously authorized expenditures to be moved from one expense line item to another where expenses were unanticipated in the FY 2024-2025 Town Budget; and

WHEREAS, on June 24, 2024, the Council for the Town of Hanna, Wyoming (Town) adopted Ordinance 404 for the annual appropriation of the Town for the Fiscal Year July 1, 2024 through June 30, 2025;

WHEREAS, there is a need to adjust the Town's 2024-2025 budget to transfer unencumbered funds in the Chokecherry Fund from the Rec Center Department Veteran's Park Improvements line item to a new expense line item in the General Office Department Town Hall Roof Project.

WHEREAS, the Council authorizes transferring unencumbered funds within the Chokecherry Fund from the Recreation Center Department Veteran's Park Improvements to the General Office Department Town Hall Roof Project line item in the amount of sixty two thousand eight hundred sixty eight dollars (\$62,868.00), leaving the Chokecherry Fund balanced and in compliance with Wyoming State Statue 16-4-112;

<u>Section 1.</u> That the foregoing recitals are incorporated in and made a part of this resolution by this reference.

<u>Section 2.</u> This resolution shall become effective immediately upon its publication.

NOW, THEREFORE, BE IT RESOLVED by the Council that the Town of Hanna budget, as so revised and altered, be adopted as the official Town of Hanna budget for the fiscal year ending June 30, 2025.

BE IT FURTHER RESOLVED, that the above appropriations, as provided for in Resolution 2024-609, be made for the fiscal year ending June 30, 2025 and that the expenditures of each office, department or spending agency be limited to the amount herein appropriated.
